

WSHSRA BOARD MEETING via Zoom

Called to order by President Tygh Campbell at 7:00pm

Sue motioned and Scott W 2nd to approve the meeting minutes from the last meeting. Motion passed

TREASURERS REPORT – Tygh reported for Tracy as she was not on the call – \$107,979.53 in Checking, \$41,281.28 in Scholarship, \$4,171.26 in Central Entry, \$75,228.73 in CD and \$2,590.39 in Savings. Tracy did make a tentative budget and emailed it to Tygh and Tashia for review. This will be sent out to the board as soon as Tashia can get it saved in a .pdf format that is attachable to an email. Tashia will also send it to the membership in the weekly email. This will NOT BE THE FINAL BUDGET until voted on in January. This is a rough draft, and if anyone has questions once reviewing this budget, they need to reach out to Tracy or Tygh PRIOR to the board voting on it.

SECRETARY REPORTS - *Shelby – Not on the call but let Tashia know that she did not have anything to report this month **Tashia – No new HS members, no club rodeo bids yet.

HS NATIONAL DIRECTOR – Sue has talked with the National Office and is keeping up with the national board. There is 1 state that had to cancel/postpone one of their fall rodeos due to the EHV virus, and will be holding it in the spring. The National Office is set up in Vegas for the NFR and ready to meet new people this year. There will be representatives from the Lazy E, Kansas and another state talking with us at the mid-winter meeting in hopes of getting Nationals hosted in their state.
